What data do we collect?

MaryElizabethBradford.com collects the following data:

- Personal identification information (Name, email address, phone number, etc.)
- IP Address

How do we collect your data?

You directly provide MaryElizabethBradford.com with most of the data we collect. We collect data and process data when you:

- Subscribe online or place an order for any of our products or services.
- Voluntarily complete a form or post a comment on our blog.
- Use or view our website via your browser's cookies.

How will we use your data?

MaryElizabethBradford.com collects your data so that we can:

- Process your order and manage your account.
- Email you with special offers on other products and services we think you might like.

When MaryElizabethBradford.com processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

How do we store your data?

MaryElizabethBradford.com securely stores your data in our e-marketing program, 1ShoppingCart, and payment processor, Authorize.net.

MaryElizabethBradford.com will keep your general contact information and form entries for indefinitely or until request is made to MaryElizabethBradford.com to remove the information. Credit card information is stored for 30 days. Once this time period has expired, your card number is automatically redacted.

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop MaryElizabethBradford.com from contacting you for marketing purposes.

What are your data protection rights?

MaryElizabethBradford.com would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request MaryElizabethBradford.com for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that MaryElizabethBradford.com correct any information you believe is inaccurate. You also have the right to request MaryElizabethBradford.com to complete the information you believe is incomplete.

The right to erasure – You have the right to request that MaryElizabethBradford.com erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that MaryElizabethBradford.com restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to MaryElizabethBradford.com’s processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that MaryElizabethBradford.com transfer the data that we have collected to another organization, or directly to you, under certain conditions.
